Easy Project is a member of International Project Management Association, therefore you can run your project according to it's standards.



According to Project Management Institute, the project is broken down into the five process groups agreed upon by the PMI and documented in the Guide to the Project Management Body of Knowledge (PMBOK).

Run your project according to **IPMA & PMI** in Easy Project:

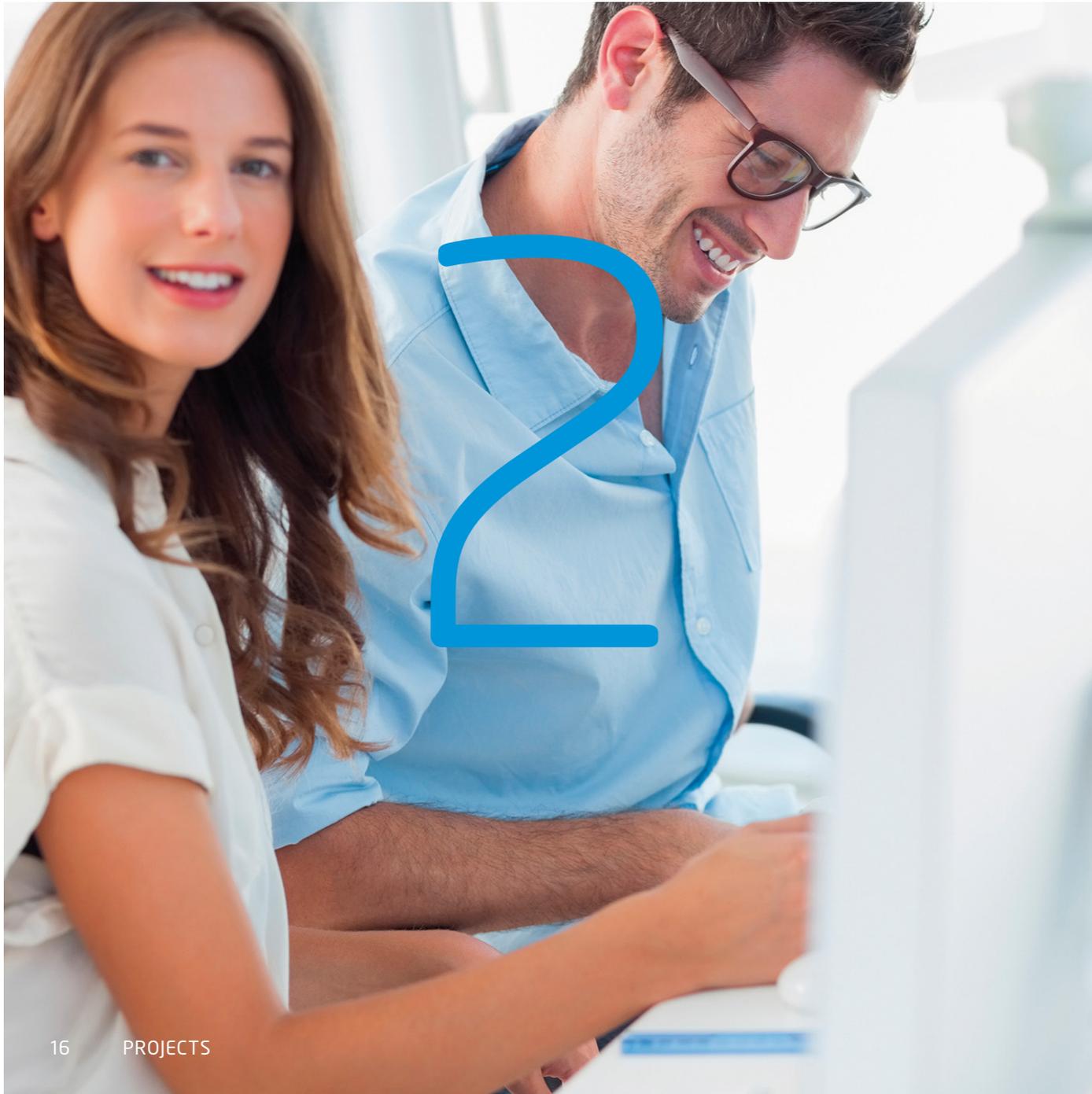
- Prepare and break-down your project in **WBS** (Work Breakdown Structure).
- Create a **Knowledge base** of good practises for your future projects.
- View the **critical path** of your project.
- Pre-defined **user types** of Project Manager and Project Team Members.
- Plan and manage the project as a **Project Manager**.
- Manage your **team** of project members.



In PRINCE2, a project is a temporary organization that is created for the purpose of delivering one or more business products according to an agreed Business Case.

Run your project according to **PRINCE2** in Easy Project:

- Start a project by appointing a Project Manager and your project team with our **Resource Management** extension module.
- Prepare a project brief and save all your project documentation directly in the **project description** or in our DMS plugin.
- Design a plan by planning tasks in **WBS** or **Gantt**.
- Identify activities and create dependencies in **Gantt**.
- **Estimate time** for each task for accurate planning.
- **Schedule** your tasks in Gantt and see if you are on track, save baselines to analyse how has the project been changing.
- **Update** your project documentation as you go and keep a track of all updates in tasks and in the project documentation.
- Create a **workflow** to set up the responsibilities and make sure the Project manager has to review every phase to evaluate the success of the project so far.
- Generate reports for **resources** and **finances** to see if you are in line with plans stated in the business case, or if something has changed.



Chapter 2

Waterfall & agile

The number of project management approaches is infinite, but basically we recognize two types - *waterfall* & *agile*.

The waterfall approach is the most useful on projects where the scope is well defined and it is the key element of the project, such as building a house and planning a conference.

Agile approach should be used on projects where time is fixed, resources are a defining factor and scope is a subject of planning (prioritization), such as during SW development (sprints), publishing (release date of magazine, newspapers) or marketing content (campaign).

2.1 Waterfall approach

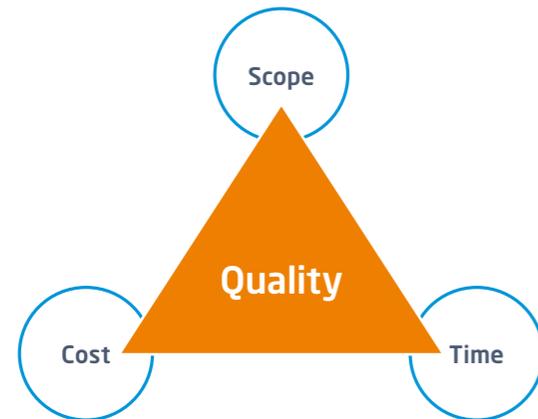
Scope (a project idea, vision) is defined and a plan is created *to reach the scope*.

By *IPMA & PMI* (International Project Management Association and Project Management Institute) the best tool to define the project scope is *WBS* which is basically the project's mind map that defines deliverables and tasks needed to deliver them.

Tasks timing is defined using *Gantt* - a time plan with milestones (basically deliverables due dates).

Resources to do the tasks are defined in *Resource Master Plan* - tasks are assigned either to people or machines and *Budgets* are allocated to the tasks or milestones.

The art of managing waterfall projects is in constant reviewing and change management of plans of time and resources. And in maximal utilization of available resources.



The Iron triangle scheme

The Project Management Triangle is used to analyze projects.

Principles:

- The quality of work is constrained by the project's budget, deadlines and scope (features).
- The project manager can trade between constraints.
- Changes in one constraint necessitate changes in others to compensate. Otherwise, quality will suffer.

How to run typical projects - which modules should I use?

This chapter will provide you with a sample project lifecycle and help you with using the right modules in different project phases.

2.2 Agile approach

What is agility?

1. **The power** of moving quickly and easily; nimbleness;
2. **The ability** to think and draw conclusions quickly; intellectual acuity.

Scope *is not* defined exactly, some minimal *delivery or improvement is wanted* to deliver quickly and to get instant feedback from real usage. Make a little step forward. It is based on the Japanese art of Kaizen - *little continuous improvements*. It was implemented into business as Kanban in Toyota and various future Agile Methodologies as *Scrum* or *Scrumban*.

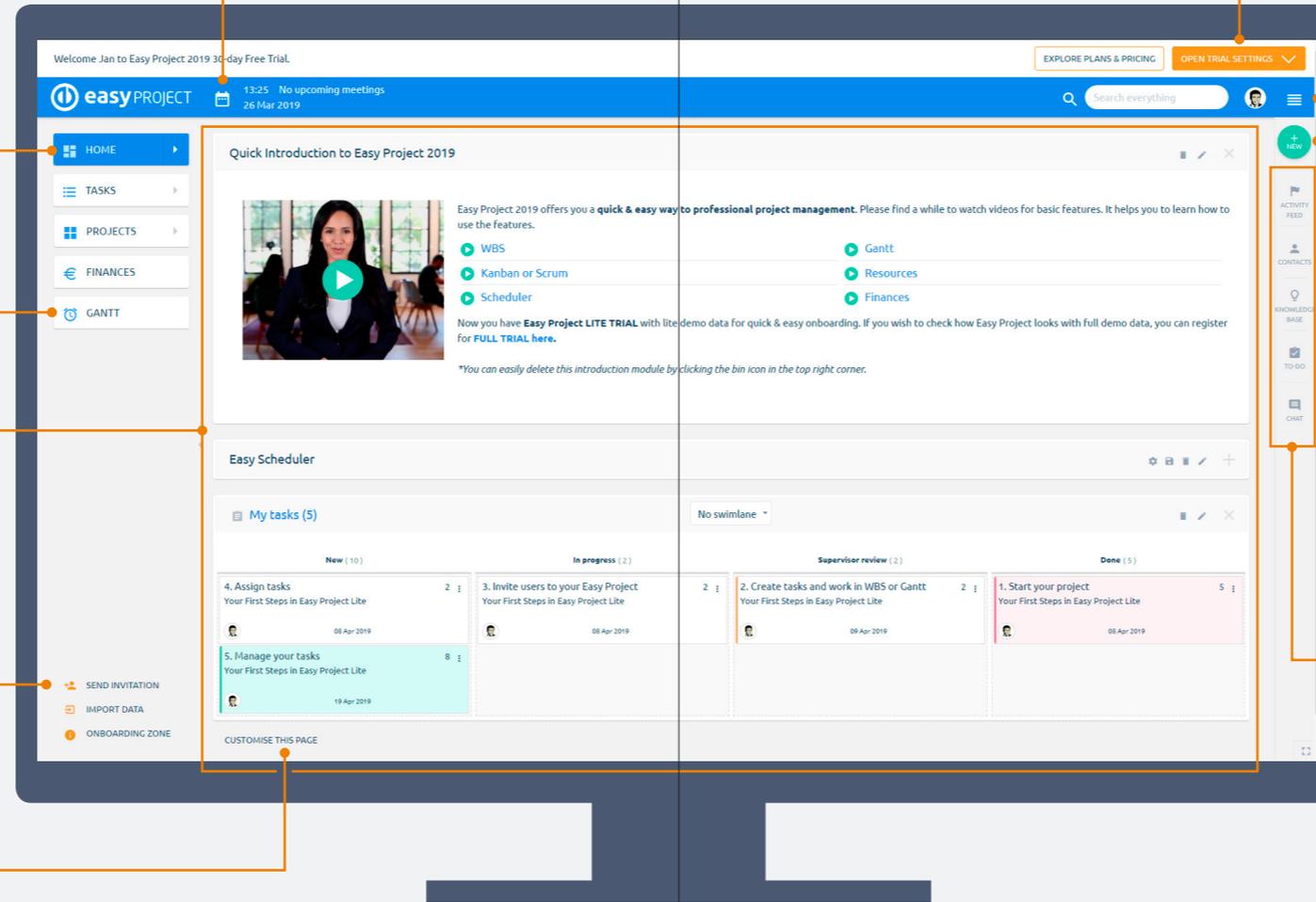

2 Clear demo data and set up your domain

Prepare Easy Project for your own projects. Clear Easy Project demo data and set up your own domain - i.e. mycompany.easyproject.com.

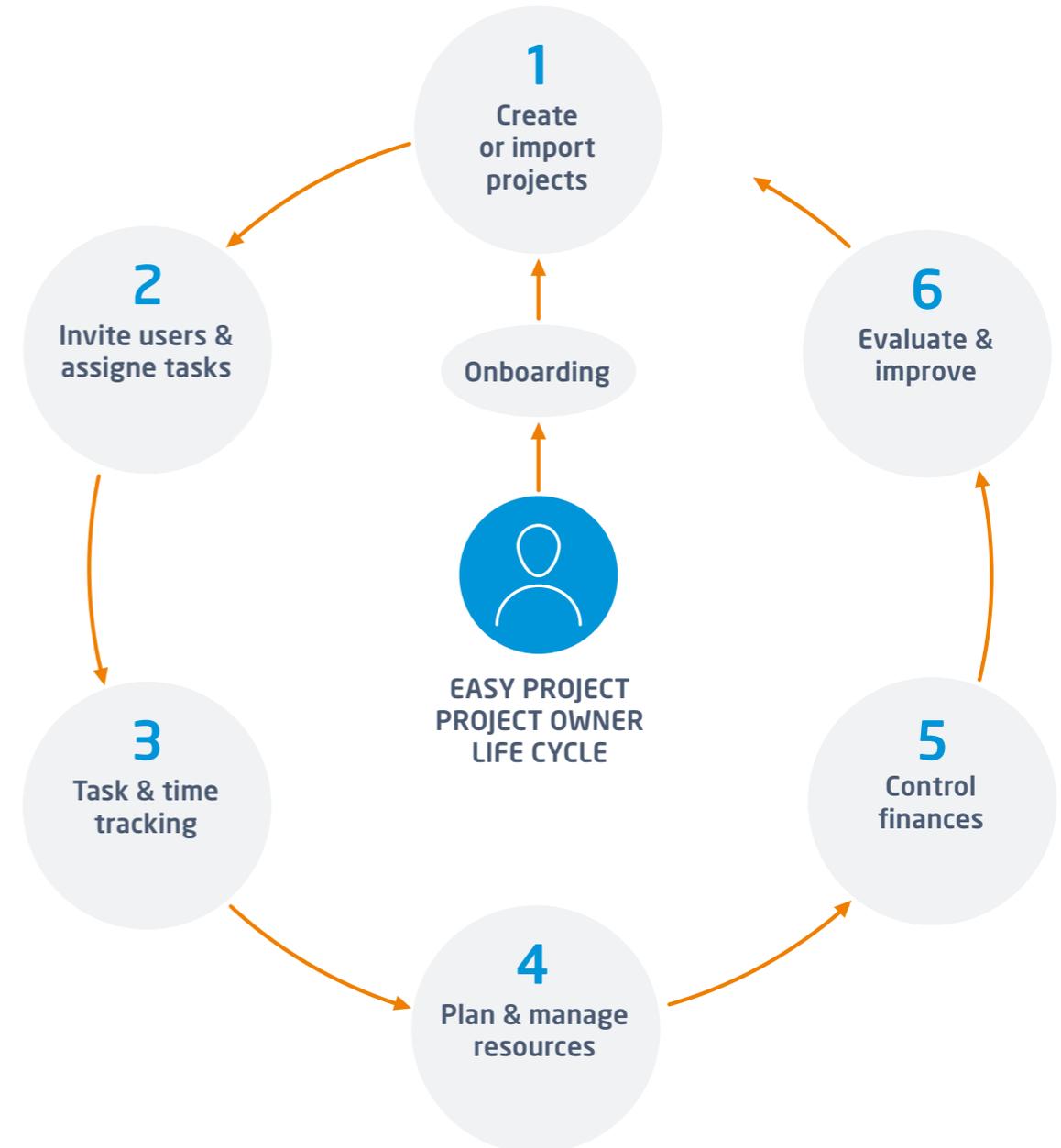

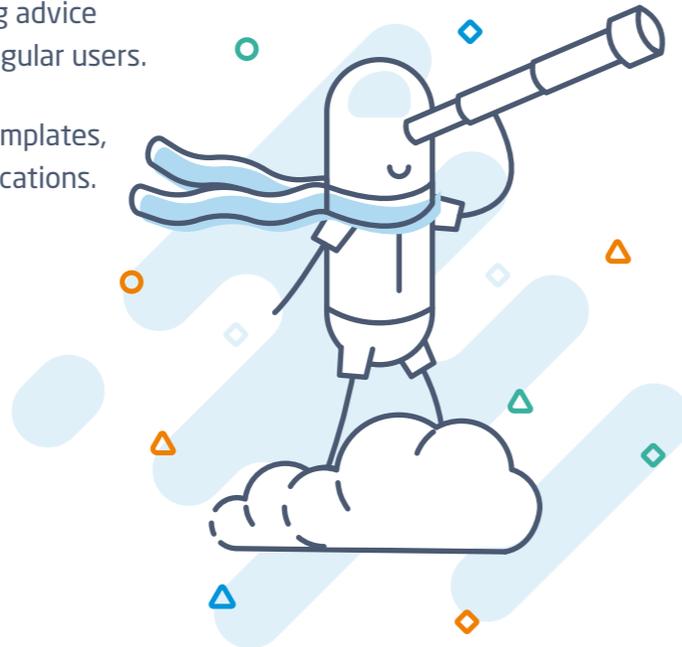

Chapter 4

Roles & user types

For easy onboarding and to ensure maximum efficiency, there are **4 role levels** (Director, Management, Executive and External) with **15 predefined user types** in Easy Project. Each user type has a **ready to use dashboard** with features according to particular responsibilities. Complete permissions and workflow are defined for each role level. Workflow for each level is also present.

This makes Easy Project implementation as easy as setting up just one option for each user - select their user type.

However, infinite possibilities of any custom set-up are kept, as well as dashboards customizations.

Manage & plan projects using WBS, Gantt and Resource Management. Manage teams using Scrum & Kanban boards. Monitor projects KPIs using budgets and time reports. Manage people using task & time tracking.

EXECUTIVE

Manage assigned tasks in a list or Kanban. Log spent time on projects using task update or a calendar. Plan Attendance and monitor personal KPI.

EXTERNAL

Use the system in a limited mode for Help Desk purposes or external cooperation on tasks.

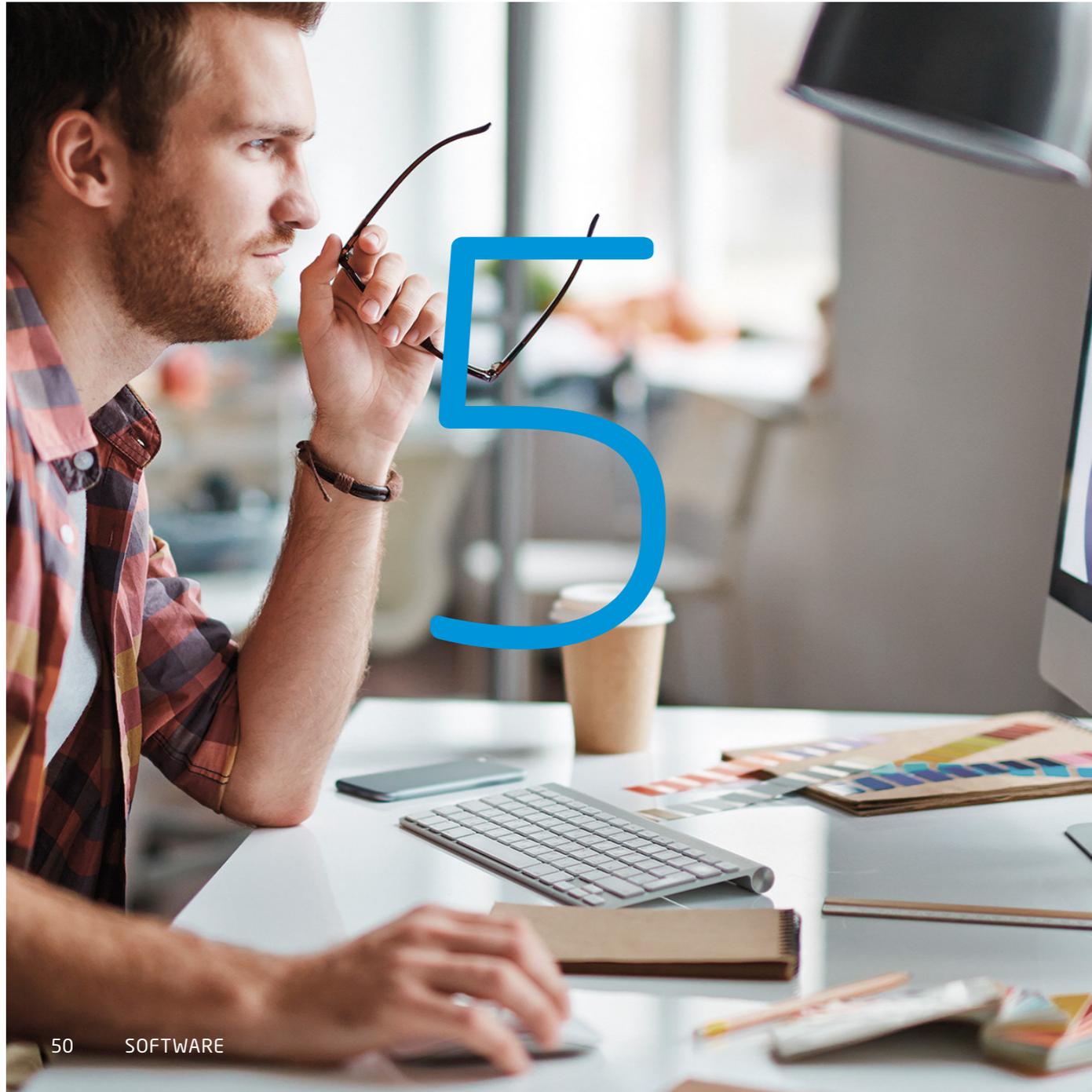

Chapter 5

All the features for waterfall, agile, task tracking, time tracking, budgets and resource management *are set-up* in default settings.

Time tracking

Time tracking and reporting is the key to efficient time management and planning. It allows employees to efficiently utilize and report their time, and managers can monitor spent time and use it as a reference for future project planning.

Logging time

- **SPENT TIME CALENDAR**
Log time in your spent time calendar. Choose which project and task you were working on, how much time did you spend on it, and add a comment as well. Choose what type of work activity did you perform, such work, support, development etc. Use a tick box to determine whether it is a billable or non-billable activity.
- **TASK UPDATE**
While updating a task you can log your time there as well. Go to **SPENT TIME** and add number of hours, choose the activity and use a tick box to determine whether it is a billable or non-billable activity.
- **STOP WATCH**
You can use a stopwatch on a task to track the time you spend on the task. Simply click on **START WORKING** and when you need you can **PAUSE** or **FINISH**.

WBS - Work Breakdown Structure

By **IPMA & PMI**, WBS is a must have tool for **project decomposition** (definition of project scope). Why? Because it provides a mind-map view.

In Easy Project, **WBS** is one of default project modules with drag & drop feature, keyboard shortcuts and complete information about every single task. It also visualizes structure of subprojects. In Easy Project task type deliverable serves as a product.

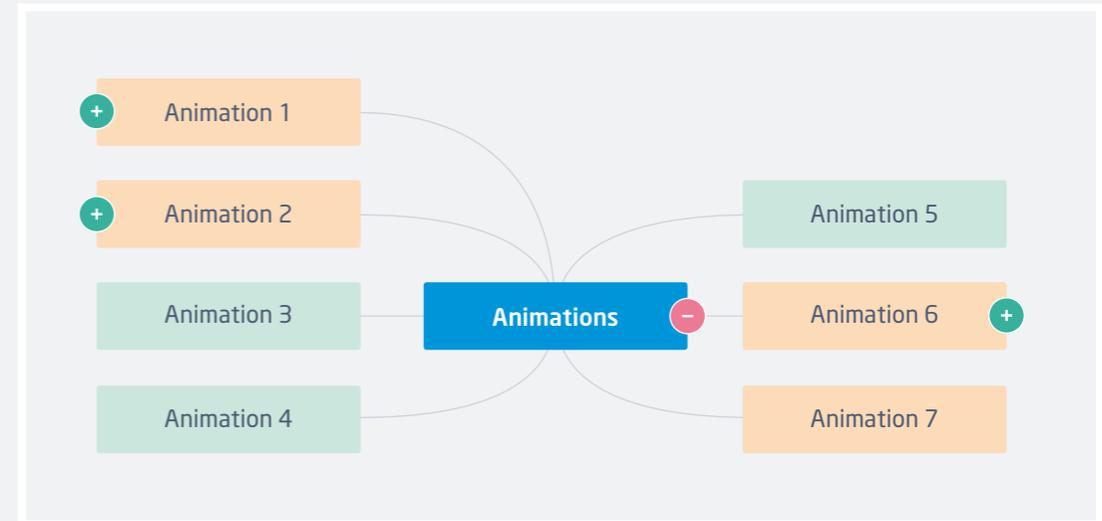

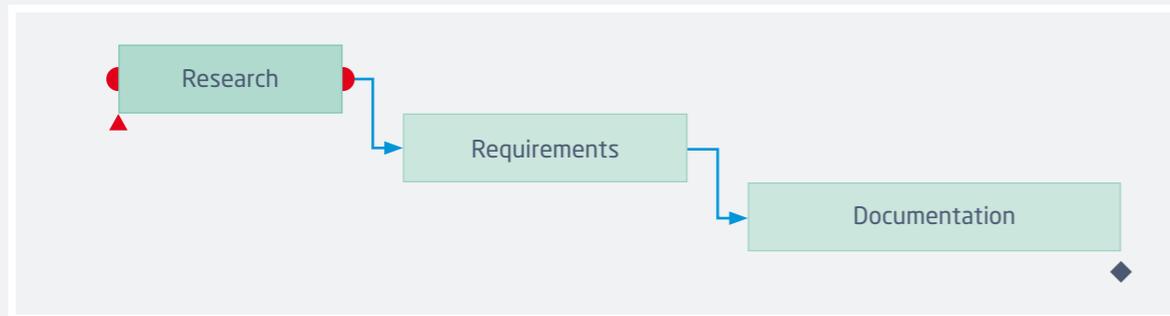
Waterfall project management



Gantt chart

Gantt with relations is basically a core of waterfall project management. Easy Project Gantt visualizes:

- Tasks
- Subtasks
- Milestones
- Relations and delays on relations
- Critical path
- Baselines
- Assigned resources (estimated time in hours)
- Assigned finances (real or planned incomes & costs)

Gantt chart on a global level or a project level

Gantt on a global level (Global Gantt) gives you an overview of all your projects in one chart. Gantt chart on a project level gives you an overview of tasks from one particular project. You can drag & drop tasks and create relations between tasks.

Moving a whole project in global Gantt chart will cause all associated tasks, milestones and subprojects to change their dates accordingly. Tasks are shifted to the end of the associated milestones. No cross-project relations are affected, such as precedes-follows or parent-child. Shared milestones are not affected as well, therefore, they might become invalid if they stay outside the range of the moved project.

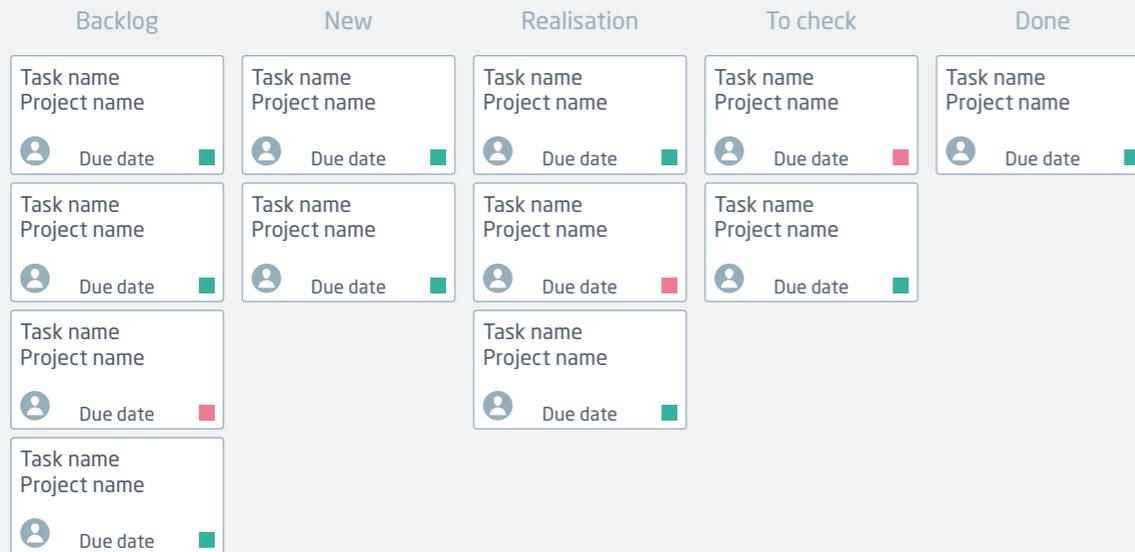
5.3 EASY PROJECT

Agile development



Agile Boards shows you sprint, backlog, tasks in backlog and their statuses. The purpose of this extension is to help you with the agile management or implementations of agile methodology into your company.

Scrum boards are used for sprints which have a specific deadline or are used for a specific time period. Scrum board is a perfect tool for Scrum Masters. Kanban board shows a constant flow of tasks and it is a great tool for Team leaders.

Scrum board

Create a new sprint in your Scrum board and use tasks from all projects. Using drag and drop function, you can move tasks from Sprint backlog to the statuses as they go through the completion progress. By moving the mouse pointer over any task in the sprint, a small window with additional details about the task appears so it's not necessary to open it every time you search for some details. In the sidebar menu, you can easily create a new sprint, switch between existing sprints or use any of the sidebar options. Next to the sprint name, there are 3 icons that can be used to edit, close or delete the sprint. By clicking on task a pop-up window with task details appears.

Resource Management on project level allows you to manage resources of a particular project. Resource Management on project level is connected with Gantt chart, therefore you can effectively work with both modules together.

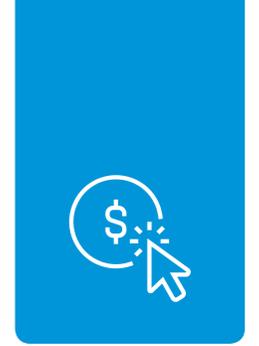

Finance management



Budget is a default project module in Easy Project.

Project module

The purpose of the Risk Management module on a project is to manage project risks in a controlled manner. The Risk management module comes preconfigured. But it is expected that each organization will customize its settings according to own internal risk metrics.

The **customizable** Risk attributes are:

Category - list of potential risk sources

Status - list of risk statuses used for risk lifecycle

Probability - definition of risk probability range used by probability & impact matrix: name, value (integer), description

Impact - definition of risk impact range used by probability & impact matrix: name, value (integer), description

Severity - definition of areas in probability & impact matrix by severity value and color. Each severity consist of name, value interval, description and color (red/orange/green/blue)

Response - list of general risk response approach options (avoid, mitigate, transfer, accept...)

To save a project as a template, go to the current project you wish to save as a template and click on the **SETTINGS ICON > INFORMATION > CREATE A TEMPLATE FROM THIS PROJECT**.

6.1 Task types

While the Software development team will work on task types Bug, in which case they would be fixing errors in the software.

Roles and permissions settings can be configured in **MENU MORE > ADMIN > ROLES AND PERMISSIONS**. Here you can see the existing roles, you can delete them, create a new one and you can also see permissions report. You may edit the name of the role and set what can the user with this role see or do. Permissions are divided into two parts - Global permissions and Project permissions. Global permissions set actions that can be done within the system, while Project permissions are actions within a project.

6.3 Workflow

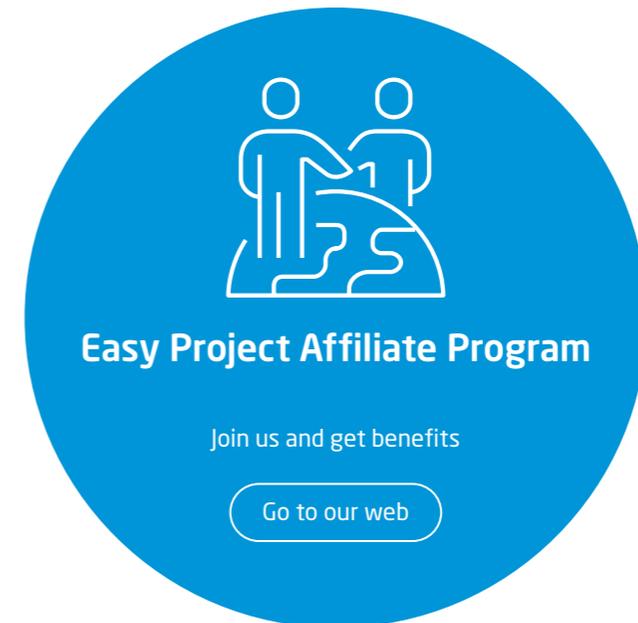

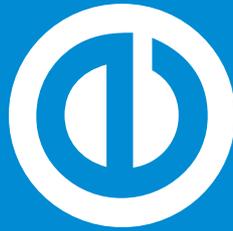
